---- The President's Message ----

As we approach the end of the school year, there have been many happenings in the district and at the state level. You have probably seen



the news about the Common Core testing and the large numbers of students opting out of the tests. This has resulted in coalitions developing among parents, teachers, students, and state officials who have participated in a dialogue which pressured officials to look at changes. Most recently, test questions have been made available to educators to help develop a curriculum that will prepare students for the tests. The State Education Department and the new Board of Regents have joined in the dialogue.

The school budget votes passed with only two exceptions in Suffolk County. Half Hollow's Board of Education and the Teachers' Association have been working together to keep the number of excessed teachers to a minimum. Presently only four are affected. The cutoff date for retiring was advanced to June 1st and, currently, there are sixteen who have applied. One of the problems with staffing is that the enrollment for Kindergartners is only 400 and we have 800 seniors graduating. That will cause reductions in sections for some time ahead. Rich Haase, TA President, has just completed negotiations for the Paras' new contract which seems to be an improvement over the old one.

A new State Education requirement may also affect Retirees. All teachers with permanent certification will have to register every five years beginning with the 2016 school year. Presently, the law requires all teachers to notify the State Education Department of their intentions in July and then register during their birth month every five years. There is no fee unless you fail to do this and then a fine of \$10 per month would be imposed. This would apply to any retiree who wants to maintain certification. There should be more details coming in July.



Traveler's Assistance Update

A few years ago we notified our members of a free NYSUT Travel and Medical Assistance Benefit underwritten by MEDEX. NYSUT Benefit Trust is **NO LONGER** affiliated with this service. They have replaced it with a new program called *EUROP* <u>ASSISTANCE</u> from Chub Travel Assist. This is an enhancement to your no-cost-to-you Accidental Death and Dismemberment Insurance you are automatically enrolled in as a NYSUT member.

The program puts you in touch with a network of providers that can address the medical and legal needs of travelers. So if you, or a covered family member traveling with you, become seriously ill, need a prescription refilled, require a legal referral, or lose your passport when traveling, EUROP ASSISTANCE can help you. To ensure that you are well-prepared before your trip, the program provides access to essential information such as travel advisories and immunization requirements. HART. . . On The Road

Recently, my husband Bill and I had the opportunity to visit Cuba which had not been open to U.S. travel for more than 50 years. Since I live in Boca Raton Fl., this was a 36 minute flight from Miami.

We landed in Jose Marti airport in Havana, Cuba's colorful Capitol. On the way to our super modern Hotel Melia we saw Spanish Colonial architecture dating back to the 16th century. colorful American made cars (shiny and new looking) from the fifties, and musical groups in the streets.

We drove through the Malecon and Plaza De Revolution (a symbol of Cuba's struggle for independance). There were great statues of Che Guerara and Fidel Castro and Jose Marti. We toured Hemingway's home and The National Hotel (made famous by Hollywood stars in the 50's). We also saw many buildings among crumbling streets.

We traversed the country from Havana to Cienfuego to Trinidad. We saw houses built of pottery, tobacco farmers (who taught us how to painted cigars). rainforests. mountain roll peaks, rivers and caves

American dollars are not accepted in Cuba. There is no internet service or cell phone service that we could access.

This experience was enlightening and disabused us of many predjudices that we had.

In August of 2015, I took a trip to the West Coast of Greenland and the Canadian High Arctic. (After having been to Antarctica, I felt I should go to the opposite end of the world.) There were 94 of us from all over the world along with 13 staff lecturers from six different countries. Of the five Greenland stops, the most northerly village was Qaanaaq and the most northerly Canadian High Arctic stop was at Ellesmere Island. We followed the 'footsteps' of British explorer. Sir John Franklin, who on his third expedition 1845-47, disappeared with 129 men in the search of the Arctic Northwest Passage.

The Inuit of Qaanaq, Greenland, still hunt for a living as they only get supplies from Denmark once a year and the Canadian Inuit on Grise Fjord, Ellesmere Island, only get supplies once a year. One is only allowed to play with sled dog pups which roam freely. If a full grown dog (usually tied up and kept far from walkways) bites a person, the dog must be killed and there goes the owner's livelihood.

We saw the monument to Matthew Perry and the graves of four men who died in search of Franklin (one man came from the Pacific passage and three came from the Atlantic passage) on Beechey Island; two glaciers; many icebergs (but not as many or as big as in Antarctica); Thule ruins from 500-800 years ago; many birds, polar bears (not up close), a walrus, and seals. I really enjoyed the expedition hikes, zodiac excursions, cultural demonstrations, interesting talks with visuals, but I was disappointed not to see any narwhals and musk ox. Well, there are still other places in the Arctic to visit in the future. Knock on wood. Joan Oanecek

The HHHART Annual Meeting

What a wonderful informative meeting HHHART had today! Meeting at the NYSUT office, thirty plus retirees convened to enjoy friends, coffee and nosh, and to catch up on what is happening with the active teachers and on the issues facing the retiree.

Joan Petroske, HHHART President, and the Board presented an interesting agenda. Joan introduced our Board and the President of the active Teachers' Association, Richard Haase, who discussed the challenge of declining enrollment in HHH and the State Budget, remarking that this year has been good for State aid to the districts. (See Joan's message on page two for more information.) Of concern is the plight of the paraprofessionals who are members of our union. They are actually paying up to 40% of their health insurance and bringing home very little in their paychecks.

Joan introduced the Board and advised us of upcoming events. Malinda Dobrins, HHHART Secretary, asked for volunteers to help with the dues collection. She also explained the need for a person to take care of our e-mail correspondence. The Board is actively seeking help in this area.

Next on the agenda was Dick Lee who is our Welfare Trust Administrator. Dick stressed that we must be vigilant in keeping our union dues paid, as we risk losing NYSUT benefits and the HHH Excess Medical (if you are enrolled). He strongly suggests that we set up some sort of "Third Party System" whereby you have designated someone else to pay your dues in case you become unable to take care of your bills. On another topic, Dick mentioned a change in the Traveler's Assistance through NYSUT. The new program is called *Europ Assistance*. He provided those of us at the meeting with handouts on this program, Eldercare, and the Health Advocate. Mel Stern, our Political Action Coordinator, got us up-to-date on what was going on in the State.

• He will be meeting with assemblymen to focus on fixing the APPR, the testing system, and insuring that the voucher bill doesn't take more from public schools,

• Mel stated that we were successful in getting change on the Board of Regents. Most of the current regents are against Common Core testing. A coalition of teachers, parents, regents, and higher education are at odds with Governor Cuomo.

• The State is putting some districts in "receivership" – meaning that the state can take over and make decisions for the school district. The Union is against this.

• There are bills going through the legislature to give districts more aid.

• The Friedrich's decision was discussed. The next Supreme Court Justice will have the opportunity to influence the future of this decision.

• NYSHIP buy back: Cuomo has proposed to eliminate buy back, which is the spousal rebate, if there is duplicate insurance.

• In November, 2017, there may be a proposition to open a Constitutional Convention. Free education K-12, more money to charter schools. teacher guarantees, retirement money can be changed. The dilemma is how to convince the public to vote against this.

Mel also reminded us of Verizon being on strike. (After our meeting, the strike was settled.)

We learned a great deal at this meeting.


